Centre Volunteers in Medicine (CVIM) is a community effort to help our neighbors in need. These neighbors work alongside us in our community as bus drivers, restaurant workers and cashiers. Some are recent college graduates looking for jobs, while others are starting up new businesses. They do not have access to health insurance or are unable to afford it. As the economy continues to challenge many of us, these workers are finding their limited resources stretched even further as they try to pay for ever more expensive food, gas, and heat for their homes. Thanks to your support, CVIM is here to take one worry away, by providing healthcare, at no charge for these families.

We couldn't do it without your support in so many ways – we depend on volunteers for more than 12,000 hours of donated time every year. We are led by a volunteer Board of Directors, all of whom are members of the Centre County community. Local health care providers, such as Mount Nittany Medical Center, Geisinger, 611 MRI/CT, Centre Diagnostic Imaging, and Pediatric Dental Care provide donated services to our patients. We also depend on you to financially support the organization.

Now more than ever, we need your support. While we recognize that we are making this request during difficult financial times, we hope that you will join us in meeting the very generous challenge offered once again by Lance Shaner, Chairman and CEO of Shaner, and his wife, Ellen. The Shaners have pledged to match up to \$50,000 of all donations made in December.

CVIM operates on a very tight budget. The impact of your tax-deductible donation can be doubled by joining the Shaners in giving the gift of health this holiday season. Get a Tax-Free Rollover

Did you know you may benefit from making a gift to CVIM from your IRA? The IRA Rollover provision was extended to December 2009. Gifts under this legislation: (1) count toward required minimum distributions, (2) are excluded from gross income – A TAX-FREE ROLLOVER, and (3) count towards meeting the Shaner Holiday Challenge for CVIM. Contact your financial advisor for details.

To qualify:

- You must be 70 ½ or older at the time of the gift
- Transfers must be direct from the IRA to the charity
- Your IRA gift cannot exceed \$100,000 per taxpayer
